Requirements

A reputed Contractor/SHG's having an experience of at least one year of running of **Fruit & Juice Stall** in a Govt. sector/PSUs/ Educational Institutions/ repute Private institutions is eligible to apply for providing services to approximately 3000 students and 150 Staffs on daily basis. The menu and rates are mentioned in the Bid Document. Further, persons visiting College for various activities may also avail of services from the **Fruit & Juice Stall**.

Charges payable by Contractor: Maintenance charge per month as per successful bid + Taxes (if applicable), Water charges @ Rs.200/- Per Month and Electricity charges on actual basis per month or fixed basis @700/- until sub meter is installed.

- 1. Each bidder compulsorily enclose a Demand Draft of Rs.5,000/- (Rupees: Five thousand Only) favoring of Principal, Govt. College Sector-1, Panchkula, payable at Panchkula as EMD even though they are having exemption from paying of EMD, for the above Fruit & Juice Stall Services and the same will be refunded to the unsuccessful tenderers within a reasonable time after finalization of the contract. No interest on EMD will be paid.
- 2. Period of Contract will be from the date of Agreement till 30th June 2025.

Terms & Conditions for Fruit & Juice Stall Contract for Session 2024-25

- 1. Duration of the contract will be effecting from the date of allotment/ signing of contract till 30th June, 2025.
- 2. Three months maintenance charges + Three months fixed electricity charges will have to be deposited in the college office as a refundable security, immediately after the contract is awarded.
- 3. The vendor has to provide good quality Seasonal Fruits, Fruit Chat and Fruit juices at mentioned prices.

- 4. a) Monthly Maintenance Charges will be payable by the contractor as per the highest successful bid.
 - b) The bid will start from base amount of Rs. 800/- Per Month with higher bid in multiplication of Rs. 50/-.
 - c) Electricity charges will be as per reading of sub meter or fixed amount of Rs. 700/- per month till the sub meter is installed.
- 5. The Contractors should have sufficient number of helpers for prompt service. Employment of Children below 14 years of age as per Labour laws in force is strictly prohibited.
- 6. Glassware used should be clean, however separate Juice Mugs in good condition for the staff will have to be used throughout the session and there should be provision for disposable glasses too. Plastic disposables are not allowed.
- 7. The College contract committee will inspect periodically the quality of fruits and juices, cleanliness and hygiene of the place allotted to the Juice Vendor.
- 8. Contract can be terminated at any time, if the work and conduct of the contractor or his service staff is found unsatisfactory.
- 9. In case of the college Fresh Juice outlet is found closed for continuous 7 days during working days in a month, the security amount will be forfeited and contract will be terminated.
- 10. No outsider will be allowed to use Vendors services.

- 11. The Contractor will get Police Verification of antecedents of all employees and submit necessary information in the office.
- 12. This facility shall be provided for the students from 8:30 a.m to 4.30 p.m on all working days. Service hours to be extended in exam days or as directed by the college authority.
- 13. Maintenance & cleanliness of Juice Stall and Surrounding area will be the sole responsibility of the contractor at his/her own expenses.
- 14. Rates of fruit and juices can be changed with the approval of college contract committee, keeping in view the seasonal change in market rates. Rate list needs to be displayed.
- 15. Use of tobacco and any kind of drugs is an offence and if contractor is found to be involved in these activities, his/her contract can be terminated at any time and security amount will be forfeited.
- 16. Two dustbins one is of Green Colour and one is of Blue Colour should be fixed up by the contractor for Dry and Wet Garbage Separately. The Garbage disposable arrangement should be done by the contractor himself/herself only.
- 17. Fine of Rs. 100 per day will be imposed on contractor if rent will not be deposited by 10th of every month.
- 18. College Administration reserves the right to cancel/ terminate the contract in the best interest of students and administration.
